



Fire Flow Test Request Form

Please pay fire flow test fee of \$225*, fill out all form information below, and return form to fireflow@englewoodco.gov. The City will conduct a fire flow test on hydrants closest to the property. Results of the fire flow test can be used by the Design Engineer to size taps and design internal plumbing within the building. The City will also verify the water system has sufficient capacity for the development by running a hydraulic model. Results of the fire flow test and hydraulic model will be returned to applicant. If fire flow test results are more than 12 months old, a new test is required.

If **only** a fire flow test is required and no additional City reviews or analysis will be required, the fire flow test can be paid by check to the Englewood Utilities Department made out to **City of Englewood**. If preferred the check can be mailed or the check can be dropped off at the Utilities Front Desk at the Englewood Civic Center located at 1000 Englewood Pkwy, Englewood, CO 80110. The check must reference the property address. If the check will be mailed, please address the envelope "**Attention: Utilities Department, Englewood Civic Center, 1000 Englewood Pkwy, Englewood, CO 80110**".

*Beginning in 2023 and per the 2023 Schedule of Fees and Rates, Englewood Utilities will charge developers fees for staff and outside consultant time to review water and sanitary sewer plans for proposed developments as well as conduct fire hydrant flow testing. Applicable tasks include reviews prior to an issuance of a permit associated with zoning, PUDs, Major and Minor Subdivision permits, Conditional Use Permits, all other permits required under Englewood Municipal Code Title 16, and associated tasks. Fees associated with plan reviews of single-family, owner-occupied properties will be waived. Fees will be deducted from a deposit provided by the developer at the beginning of a project. For residential developments with four (4) or less units, the minimum deposit is \$1,000. For commercial, industrial, or residential developments over four (4) units, the minimum deposit is \$5,000. Upon final approval of the building permit, the remaining amount in the deposit will be returned to the developer. If needed, an additional deposit may be requested during a project if the initial deposit is expended. Prior to any Utilities reviews of development plans or system capacity verification, other than preliminary reviews completed as part of a Development Review Team (DRT) meeting, developer is responsible for coordinating with City staff to sign a Public Sanitary Sewer System Connection Application and/or Public Water System Connection Application and providing the City with the required deposit amount.
