Please see previous Council requests 07-203 and 15-084 (attached).

During the winter the Colorado Department of Transportation (CDOT) is responsible for plowing certain roadways in Englewood to include Hampden Ave. (Highway 285). When they plow these roads, the snow is often pushed onto the sidewalks along the roadway.

Per our ordinance, the property owner is responsible for clearing their sidewalks within twelve (12) hours from the time of the last accretion of such snow or ice.

This causes frustration for property owners because they have to repeatedly clean off their sidewalks. The snow that gets plowed onto the sidewalks often has the consistency of concrete and is difficult to remove if not done immediately.

Unfortunately, we don't have many options.

We have approached CDOT previously; however, they are allowed to do this by state statute. Their priority is to plow the roadways, even if it means that they need to push snow onto private property and/or rights-of-way which need to be maintained by the property owner.

Sidewalks with snow and ice are a hazard to pedestrians and need to be cleared off in a timely manner. We typically issue the property owner a Notice of Violation before resorting to a citation. We just need to be consistent in our enforcement approach citywide. If we ask other property owners to remove snow within 12 hours, we would be hard pressed to give certain property owners more time.

Signage could be placed by either Public Works or the property owner advising pedestrians to avoid certain sideways; however, this would not alleviate the need for the property owners to maintain their sidewalks.

A request was made for information relating to the following:

- Possible snow removal violations in the neighborhood near Floyd/Race with specific violation locations mentioned.
- Efforts regarding enforcement of snow removal ordinances as a result of the recent snow storms.
- Procedures regarding CDOT placement of snow onto residential or business sidewalks along CDOT maintained highways within the City of Englewood.

Code Enforcement Officer Larry Medina inspected the neighborhood near Floyd and Race. The following actions were taken at specifically mentioned locations:

- 2001 East Floyd Avenue: A "friendly reminder" brochure was provided to the resident regarding the lack of snow removal from the sidewalk.
- 3285 South Race Street: This location was found to be in compliance.
- 2000 East Eastman: A "friendly reminder" brochure was provided to the resident regarding lack of snow removal from the sidewalk.

Code Enforcement Officers have conducted the following activities relating to snow removal violations from the recent storms:

- As of January 2, 2008, ninety-five snow removal violations were observed or reported.
- Of those ninety-five cases, approximately three to five are not yet in compliance with appropriate follow-up to be conducted.

The Colorado Dept of Transportation (CDOT) provided the following information regarding the removal of snow from state highways (Hampden Avenue, Belleview Ave, Federal Blvd, and Santa Fe):

- CDOT representative Jerry Johnson was contacted by Englewood Code Enforcement Officer Larry Medina.
- Mr. Johnson advised that CDOT is only responsible for clearing snow from the traveled portions of the roadway (curb to curb). Snow that is removed from the state highways cannot be plowed onto the median or into turn lanes due to liability as well as the blocking of the turn lanes and lanes adjacent to the medians. Snow from the state highway is therefore placed onto sidewalks or private property that abuts the state highway.
- Mr. Johnson refers all such inquiries to the local jurisdiction to enforce per that jurisdiction's municipal ordinances for snow removal from sidewalks.
- Per Mr. Johnson, snow placed onto sidewalks or private property along state highways is not the responsibility of CDOT, per Colorado Revised Statute 43-2-135(1)(a): Division of Authority Over Streets, as outlined below:
- (1) The jurisdiction, control, and duty of the state, cities, cities and counties, and incorporated towns with respect to streets which are a part of the state highway system is as follows:
  - (a) The city, city and county, and incorporated town shall exercise full responsibility for and control over any such street beyond and including the curbs and, if no curb is installed, beyond the traveled way, its contiguous shoulders, and appurtenances; except that the regulation and control of driveways shall be subject to the provisions of section 43-2-147.

Placing signage directing pedestrians to use the north sidewalks along State Highways during adverse weather conditions.

The traffic engineer would be responsible for placing signage under adverse traffic/pedestrian conditions if and when it is deemed appropriate.

The core issue is, Colorado Department of Transportation (CDOT) clearing the highway (Belleview and 285) and displacing the snow and ice upon the sidewalks. CDOT's priority is clearing the roadway and they are aware of the negative impact of discharging the debris onto sidewalks. I have personally contacted CDOT's supervisor and he reiterated that their priority is clearing the roadway.

I have also personally met with the new manager of K-Mart regarding keeping the sidewalks clear and she will ensure the maintenance crews keep the sidewalks passable in the winter.

East of Broadway on Belleview, there signage posted no pedestrian traffic on the north side to Logan. This is due to the large utility poles erected on the north sidewalk.

The clearance and maintenance of the sidewalks along the highways has been a constant issue with both State Highways (Belleview and 285) and Code Enforcement constantly reminds the responsible business to maintain their portions of the sidewalk to ensure safe pedestrian travel. The understandable concern is that the business or property owner clears the sidewalk and subsequently, CDOT responds and displaces the road debris back onto the cleared sidewalk and the cycle continues.

Code Enforcement will continue to monitor these areas for compliance.
