**SUBJECT:** Council Short Term 15-199 – Solar Output Inquiry

### 1. Building Mounted Solar Arrays

- a. Photovoltaic solar panels have been placed on four City facilities: The Englewood Civic Center, the Malley Senior Recreation Center, the Englewood Service Center, and the Police/Fire Complex.
- b. Managed by an energy services company, AMERESCO, who installed the systems and is responsible for their maintenance and operation. The City pays for the energy the panels produce at a rate set forth in the contract documents that increases by 2% every year for 20 years.
- c. The arrays offset the facilities' need for fossil fuel generated power.
- d. All combined the arrays produced 287,533 Kwh at a cost of \$26,338.02 in 2013.
  - i. Cost to purchase the same energy from Xcel would have been \$21,564.98
- e. All combined the arrays produced 280,516 Kwh at a cost of \$26,199.91 in 2014.
  - i. Cost to purchase the same energy from Xcel would have been \$21,038.70
- f. All combined the arrays produced 220,853 Kwh to date at a cost of \$21,047.29 in 2015.
  - i. Cost to purchase the same energy from Xcel would have been \$15,901.42

### 2. Aurora-Arapahoe Community Solar Array

- a. In 2014 the City purchased a portion of the array to offset the fossil fuel generated energy used by one of the Parks and Recreation irrigation pumping stations. The total cost of the purchase was approximately \$34,000.
  - i. In 12 months of operation the City's solar panels in the array have produced over \$8,298 in bill credits for the pump station.
  - ii. The initial purchase price should be fully recovered in 2017 and the life of the solar panels is expected to be 25 years. The return on investment will exceed 400% over the life of the system.
