2. What are the requirements and time restraints for appeals to City Council from the Planning and Zoning Commission decision on Nonconforming Lots?

Appeals to City Council from Planning and Zoning Commission decisions on Nonconforming Lots are per EMC 16-9-4(A)(3) which states:

16-9-4(A)(3) Any appeal from the Planning and Zoning Commission's decision shall be to City Council as a de novo review. Such appeal shall be filed no more than thirty (30) days from the date of the Planning and Zoning Commission's final decision.

3. How and when are the appellants notified of the decision?

Per EMC 16-2-18(C) The decision of the Council shall be in writing, and a copy of the written decision shall be given to the appellant.

4. How does the City deal with ADA compliance issues?

The Englewood Civic Center building and all public hearings are ADA compliant.
