Parking Problems near the Lehigh Post Office

A recent move of a business from the 3000 Block of S. Tejon St. to 3800 S. Jason St. has resulted in numerous vehicles being brought into the area. On December 8, Parking Officer Adrian Curry went to the area as a result of a Webmaster inquiry. Officer Curry issued several citations to vehicles in the area.

I met with the business owner on December 15. The business owner assured me all vehicles parked on the streets around his body shop were licensed and operable. Due to heavy snow, I was not able to verify this information. The business owner reported he is consolidating three locations and within two weeks will get all vehicles off the street. He was warned that any unlicensed vehicles will be towed and other parking citations will be issued as appropriate. The owner was further warned of the Public Nuisance ordinance in Englewood. Officer Curry will continue to monitor the area for violations.
