SUBJECT: Electric Speed Signs

COUNCIL REQUEST NO. 17-028

Staff was asked to look into the possibility of adding additional radar speed signs throughout the City. The main objective of these "driver feedback" signs (mounted speed displays and speed display trailers) is to slow motorists down. The expected outcome is to enhance safety, minimize speeding or complaints of speeding vehicles, and lower the risk of crashes.

In most cases, a reminder in the form of a speed sign displaying the driver's speed is all that is needed to bring vehicles' speed down. However, in some cases, speeding may not be the actual problem. It has been proven by numerous studies done throughout the nation that these types of signs help reduce drivers' speeds in both the short- and long-term. Overall, evidence suggests that speed displays are a relatively low cost safety improvement that has a significant and ongoing effect upon vehicle speeds. To date, there are a total of 11 permanent installations of radar signs in the City. The signs are mounted at the following locations:

The Police Department frequently uses two speed display trailers in addition to those listed above. Speed display trailers are portable and can be deployed at any roadside location with sufficient room. These trailers are typically used on a temporary basis at locations with complaints from residents about speeding vehicles.

The Police Department recently received a grant from the Colorado Department of Transportation, Highway Safety Office, to help support speed enforcement efforts. A radar speed sign was purchased and is intended to be used at various locations for periods of times (mounted on Xcel utility poles), when deemed beneficial.

Staff supports the recommendation to purchase two or three additional radar speed signs to be used in a similar way, to be temporarily mounted on Xcel poles. Staff strongly believes that these "moving around" speed display signs would significantly contribute to the likelihood of a reduction in vehicles' speed. Furthermore, we are currently evaluating two new locations for the "permanent" sign installations - on Girard Avenue, west of Broadway, and on Zuni, in the 2200 S. block.

The cost of a new speed display sign, including installation, is typically in the range of \$7,500 to about \$10,000, depending on type of the sign and installation. We plan to purchase these two new signs using the Transportation System Upgrade funds. Other speed display signs purchases in 2017 would require additional funds, or to be requested in the 2018 budget.

SUBJECT: CR 17-047 Mid-Block Crossing – ETAC Recommendations

The Englewood Transportaion Advisory Commission (ETAC) provided the attached recommendations to improve pedestrian safety at the mid-block crossing in the 3400 block of S. Broadway.

Some of these recommendations fall outside of typical traffic engineering design guidelines and staff requests Council's consideration before implementation. Initial staff comments are provided with this memo.

PUBLIC WORKS STAFF COMMENTS

- 1. Raise & extend north side of median for pedestrian protection, possibly include flower bed like the south side already has in place. Will provide a barrier for people in the median landing area. Landscaping is not recommended in this concrete barrier. Staff has no objection and costs are being estimated.
- 2. Extend sidewalk bump-out toward oncoming traffic from crossing areas to 35 feet. Staff agrees with this recommendation to improve safety. Our observations of the operation of the temporary crossing confirm that providing additional sight distance will benefit pedestrian visibility. This requires the relocation of a storm sewer inlet, additional concrete, and the loss of one parking spot on each side of Broadway. Costs are being estimated.
- 3. Include Lighted Flashing Signs at intersection, which are activated by a button, and intended as a notice to drivers and not as a traffic regulation signal (ie. Stoplight or stop sign) Conflicting opinions regarding improved safety. Flashing lights will provide additional notification to drivers. Pedestrians may feel more entitled to walk in front of oncoming traffic. Initial cost estimate is in the \$25k-\$30k range.
 - Include a voice message when the button is pushed that says "Traffic does not stop, please wait for a break in traffic" (or something). Staff is researching this option and costs are being evaluated.
- 4. Include more festive lighting or other things in the 3300-3400 blocks to get drivers to know that there is more going on than thru-traffic on Broadway (think downtown Littleton, Larimer street, etc). At a minimum prepare the area for this in the future since we're doing work there right now. The electrical design for 3400 S. Broadway will include new electrical outlets at trees that could provide power for future lighting projects.
- 5. Text on ground on each side "Traffic Does Not Stop" or "Be Safe, Look Both Ways", or something artsy like eyes looking both ways and "Look!" *Pedestrian notification at ground level is not typical. Signs mounted at eye level (already installed) or above are easier to see during adverse weather conditions.*Maintenance costs should be considered.
- 6. Adding Flags & receptacles on each side to make people visible. This has been used in other jurisdictions (none found in Colorado). It would provide additional visibility of pedestrians. As with flashing lights, flags may empower pedestrians to try and stop traffic. Maintenance should be considered as we expect flags will disappear (perhaps local businesses could keep the flags stocked). Some jurisdictions have stopped their pilot flag program due to maintenance issues.
- 7. Consider reducing speed limit on Broadway on 3300-3500 blocks. *Traffic data collection is underway to determine impacts. Public Works staff does not believe reducing the speed limit in this section of Broadway will be a problem as speeds during peak times are well below the posted limit. Minor adjustments to signal timing should accommodate the change to 25 mph. Our final recommendation needs to wait for completion of the traffic study.*
