It is my understanding that Denver will adopt the 2015 codes in July. Englewood will adopt the 2015 codes sometime this year, but not likely in the same time frame. The Building Division is currently reviewing the 2015 IBC and will have any proposed amendment recommendations prepared for submission to a Council Study Session as soon as their review is complete, but we are not there yet.
