A request for Code Enforcement Status of Compliance on 3633 S Fox St.

On 11/25/17 a complaint was filed by Ms. Brenda Hubka regarding this property.

I conducted an inspection on 11/27/17 at approximately 8:20 AM and found the property to be in compliance with the municipal code.

This property has an extensive history of municipal code violations that resulted in multiple summons and abatements.

A roll off dumpster is located on the property and is actively being used to dispose of an extensive amount of items that were located on the property or possibly from inside the structure. The dumpster is frequently removed from the property for periods of time and the household items that were placed inside disposed of. Over the last year various sizes and colors of dumpsters have been used. The Dumpsters have been placed at various locations on the property to include the front, the back and the side yard and do not obstruct the public streets or sidewalks. The roll off dumpster is not in violation of the municipal code.

Code Enforcement does not have the authority to enter a structure so an inspection has not been done inside by Code Enforcement. Code Enforcement has been unable to obtain voluntary consent for a mutual contact inspection inside the structure and the Building Department was unsuccessful in obtaining consent as documented on 09/15/17.

I did not see evidence of rodents on the property or near the roll off dumpster. A single dumpster is not a significant contributing factor for rodents. Rodents need habitat, food and water to thrive. Within a 2 block radius of the property I found the

following potential contributing factors all of which are permitted under municipal code: multiple properties with back yard poultry flocks, back yard ornamental ponds, properties that leave domestic pet food outside and gardens that have untilled leftover vegetables.
