Follow-up information requested regarding cars parked for prolonged periods at the adult bookstore on Union and Santa Fe.

A request was made for the Parking Enforcement Officer to monitor the area for parking concerns. On April 16 he reported that he did not find significant parking issues during the day. A request was made for evening patrol officers to check the area. On the evening of April 18, 2018, officers conducted parking enforcement in the 1800 – 1900 Blk. W. Union Ave. for illegally parked vehicles. Officers located and ticket seventeen vehicles that were in violation of a parking in a no parking zone from 12:00 am to 5:00 am. Officers will continue to monitor this location. The Parking Enforcement Officer will contact local repair shops as the problem does not seem to be related to the adult bookstore.
