A request for Code Enforcement Status of 4201 S Bannock St.

The address of 4201 S Bannock Street has had 5(five) animal control violations with Englewood Police Animal Control since October 2017.

Since the initial warning was issued in October 2017, a total of four additional summonses have been issued to the dog owner.

March 2, 2018

Summons issued for Dog at Large and At Risk Behavior.
The defendant was found guilty in April 2018 of both charges by the Englewood Municipal Court.

March 7, 2018

Summons issued for Dog at Large, At Risk Behavior, and Rabies Vaccination.
The defendant was found guilty in April 2018 of all charges by the Englewood Municipal Court.

April 26, 2018 Incident at about 1500 hours

Summons issued for Dog at Large and Dangerous Behavior since the dog has had continued violations.
This case is still pending in Englewood Municipal Court

April 26,2018 Incident at about 1642 hours

Summons issued for Dog at Large and Dangerous Behavior since the dog has had continued violations.
This case is still pending in Englewood Municipal Court

Since the dog has only been deemed At-Risk by the Englewood Municipal Court, Animal Control is not able to seize the dog until it is deemed Dangerous per:

EMC 7-1A-16(F) "Dangerous Animal"

F. Impoundment. Any animal which has caused injury to any person or domestic animal or which has committed any behavior defined as "Dangerous" herein, may be seized and impounded as provided for in this Chapter.

On 6/13/18 Animal Control was dispatched to the area of 4201 S Bannock for a dog at large and aggressive. According to the complainant, the dog was at large and aggressive but has now been taken back to the owner's property. The complainant provided pictures of the dog showing it was a brown, black and white mixed breed dog. Since Animal Control observed no violations, the complainant was contacted and advised to continue the enforcement process a written statement would need to be provided. As of today, no written statement has been provided directly to Animal Control.

The at large / aggressive dog has been identified by the complainant to live at 4201 S Bannock. Animal Control has contacted the residents at this address who have confirmed the brown, black and white dog in the photograph does not live at 4201 S Bannock St.

Moving forward Animal Control can issue summons to the dog's owner once located and a witness statement outlining the at-risk behavior is provided. The Englewood City Attorney's Office has also decided on the current cases for dangerous dog the dog will not be seized until a court order has been issued since no bite has occurred.
