Requested by: CM Barrentine: Referencing the email thread below from Jacob Gilbert, I am confused how this situation continues. Please advise council on the status of this complaint as well as the process Code is using for taking complaints. Many residents are have a problem reaching Code to file a complaint, are we now advising people to call 911 to file code violation complaints?

On July 10, 2018 Ms. Monarez pled guilty to two counts of dog at large and two counts of dog dangerous behavior. She was sentenced to the following:

- \$250.00 fine suspended on each of the dog at large charges,
- \$750.00 fine suspended on each of the dog dangerous behavior charges,
- No further similar violations for one year,
- Complete NCTI-Animal Ordinance Compliance Class,
- Provide proof of current private dog training, and
- Comply with the conditions of the dangerous dog ordinance.

Due to the convictions in these cases, the \$1,100.00 fines that were suspended in cases 27314M and 27316M were imposed.

A penalty hearing is scheduled for September 14, 2018 at 10:30 a.m. to monitor the defendant's compliance with the above conditions.

Code Enforcement receives complaints via telephone messages, email, in-person contact by the community, employee initiated activities, the City of Englewood web-site, etc. Additionally, as the Code Enforcement Supervisor, Lewis requires that his employees return all outstanding email and phone messages daily before the end of each day (weekends excluded). In any emergency situation, including a vicious dog concern, it should be reported to 911. The code enforcement telephone line is for non-emergency inquiries. There are certainly situations in which a vicious

dog is creating an emergency and the victim cannot wait for the non-emergency line to be answered. There are also situations in which a dog is just running at large that may not be deemed an emergency. The victim will have to make that determination.

On August 10th, the Building Division of the Community Development Department inspected the property and found no building code violations. A stop work order was not issued.

This letter is regarding the above claim reported by the City for various roof leaks. We are providing a summary of our initial investigation findings regarding the cause of the roof leaks.

The following buildings were inspected after report of leaks and we include a note regarding our findings.

- Maintenance Admin/Shop Broken Tee Golf Course, 4000 S Clay St.

On July 25th, we visited this building. The metal roof above the office portion did not show evidence of wind or hail damage. The back shop roof has one small section of light gauge flashing material with minor hail dents. The roof did not leak due to wind or hail damage in our opinion. It is possible that the roof's gutter drainage system became clogged and the roof could not discharge the heavy rains fast enough before it found its way into the building's interior.

- Club House, Broken Tee Golf Course, 2101 W Oxford Ave.

On July 25th, we visited this building. We inspected the roof after being shown two general areas of leaks. We could not identify an obvious source of entry at the sloped metal roof or flat membrane roof above the leak in the Metagolf Learning Center. We found no wind or hail damage to the roof system. The second leak was in the restaurant dining portion of the building. There was no wind or hail damage found above the restaurant. We did find wear and tear and warped frames of the upper row of windows that face the front parking area.

City Hall City Center, 1000 Englewood Parkway

On July 25th, we visited this building. Two rooms had water intrusion. The 3rd floor conference room had visible water damage to the ceiling drywall, ceiling tiles, water marks down windows, and efflorescence marks on the stone finish. We viewed the areas above the conference room which did not have any evidence of wind or hail damage. There were no obvious points of entry for water. The Risk office on the 3rd floor also has water damage to the ceiling and water marks on the interior of windows. The areas

above and outside this room also did not show evidence of wind or hail damage. The leaks were not due to wind or hail damage to the building's exterior.

- Police-Fire Complex, 3615 S Elati St.

On July 27th, we visited this building. The ceiling, floor and personal property items in the records department were damage by a roof leak. The roof area was inspected, and we did not find any evidence of wind or hail damage. The leak may have resulted from a clogged or overwhelmed roof drain on the low slope roof area above the records department. Two areas of leaks in the police offices on the 2nd level were viewed. We did not find any wind or hail damage attributable to these leaks.

In summary, neither hail impact damage nor wind damage to the building exterior were found to be the cause of the leaks at the above structures. The interior water damage to these structures is covered by the CIRSA policy.

In addition to our inspection, we would be happy to hire an engineer to investigate and report as to the cause of the roof leaks. Please advise if you would like us to send an engineer.

City of Englewood's Mission: *To promote and ensure a high quality of life, economic vitality, and a uniquely desirable community identity.*

July 24, 2018 a storm that took the life of Rachel Haber, a day that affected citizens of Englewood, CO, a day that will be forever be embedded. A day that I'm sure the Haber's will never forget. A day that shifted the community to holding the city, the utilities department, the mayor, and city employee's accountable for their lack of compassion and genuine disregard and gross negligence of maintaining storm drains, culverts and the health and safety of their citizens. A day that became a day of displacement for families, houses destroyed, loss of income, loss of life, loss of family heirlooms. No Emergency Notification system as posted on your website, no emergency management. No mitigation, no capabilities for effective disaster response, no immediate reaction and no recovery to helping the rebuilding of affected citizens. A day that did not need to happen and one that will never be forgotten.

July 25th, a city counsel meeting consisisted of a discussion of homelessness for 45 minutes and a 15 minute update on the sink hole on Santa Fe, no discussion of effected citizens, no public comment from the city as the city was calculating it's collateral damage and certain were being advised by the city attorney as to the completion of a public statement. No city official in sight.......No help only news coverage.

City employees had to locate the original blueprints of the city to determine whose responsibility it was to maintain the culvert drain between 4640 and 4650 S. Bannock. City employees do not have chain saws; the conditions after the storm were a health and safety issue, bug infested, dumpsters were finally provided by the city on Monday, 6 days after the storm.

July 26th, official statement made by Alison Carney, communications manager. An acknowledgement of guilt of the endangerment of health and safety of the residents of Englewood. Blame of a 100-year flood. Again no city personnel in sight, a day I paid the City of Englewood a visit. A day where the building permit personnel did not acknowledge me immediately, a conversation between 4 city personnel bragging about how much the city would make from us for upcoming permits that we would have to pull. An assistant from the City manager's office came out to speak to me after a building permit employee went into that office and I could hear him say, "some crazy lady wants to speak to someone". The assistant insisted that our insurance should take care of our damage, only for me to inform her that none of us had flood insurance. That night I discovered on Englewood's website through a study dated 1998 that we are on a flood plain, this was never disclosed when we purchased this home. An area on the website that states we are in a high flood zone only to find out that we are classified on the FEMA site as minimal. The city would like to blame this on a 100-year flood even though for 4 decades this city has chosen to ignore the problem. Municipalities are liable for damage caused "by reason of the insufficiency or want of repair by failing to take remedial action to maintain it".

Floods have occurred in 1913, 1927, 1933, 1953, 1956, 1963, 1965, 1973, 2013, 2015, 2018.

The following to be addressed immediately:

Citizens affected to be compensated for their losses along with punitive damages so the city and public works will be punished for the failure of maintaining infrastructure without having to file lawsuits. Storm assistance grant of \$1,000 is no compensation for losses incurred.

Emergency and Disaster Response team to be effective in situations. Emergency Reverse 911 calls about fires/flood/storms, etc to be put in place.

Drain line from Acoma street to alley between Acoma to Bannock to be inspected with a camera <u>ASAP</u> and cleared of clogged line leading to the alley drain.

No gravel added anymore to alleys, this clogs up the drain system that already has been grossly neglected and impacts the quality of water that ends up in streets, yards and storm drains.

Official certification that drinking water and sewers have not been breached and provided to affected areas.

Chain saws to be purchased immediately to cut down trees and brush that impede the top of the culvert and any other areas in the city located near drains/culverts and alleyways.

All charges of building permits to be free and include longer time frame in completion of repairs.

Studies have already been done along with heeded warnings; it is time for implementation to happen, no more redevelopment until infrastructure is replaced. Storm water drainage currently has 1,091,105 and only 81,161 have been used with an YTD ending balance for 2018 of \$1.2 million dollars. Sewer and water will have an approximate \$22 million balance EOY 2018. Affected citizens to receive credit on upcoming water/sewer bills.

Study in 1980 is just now being remediated, 1998 study to be implemented now with the warnings addressed in report. ACT ON PRIOR FINDINGS IMMEDIATELY.

Immediate accountability that this was not a 100-year flood, flood plain to be immediately disclosed to owners/renters in flood plain and City to notify FEMA with update to reflect this change. All citizens to be officially notified that they live in a high flood area and cannot be denied flood insurance.

Urban Drainage and Flood Control District to be advised of the municipality's liability as it failed to exercise ordinary care in the maintenance and repair of drainage improvements. Drainage is supposed to prevent deterioration or obstruction failure.

Ineffective leadership and communication to the response of the crisis.

The Mayor of Englewood should be available to all citizens and personnel during a crisis/emergency, etc. Required to be available even if away on business, personal time, etc. All non-essential city employees to be required to volunteer in areas of need. All

personnel including city attorney, mayor, manager, city counsel members, etc required to be in the field and attend leadership programs.

Citizens Review Committee formed to ensure checks/balances of the City of Englewood, Public Works Department, Code Enforcement, Concrete and Sewer, budget spending, etc.

EOC to implement agencies to assist in relief, i.e., food, drinking water, etc. in the future as well as the welfare, health and safety of it's citizens.


















Flooding Recovery Grant and Building Permit Fee Waiver Information

The Community Development Department is spearheading two initiatives to support the community's recovery from the flooding that occurred in parts of Englewood on July 24, 2018.

City Council has approved (on First Reading) a temporary waiver of building permit and plan review fees to facilitate flooding repairs. Council requested a copy of the form that is being used to determine the eligibility of properties for the waivers. The form is attached. As of August 14, one building permit fee waiver request has been received by the Building Division.

Homeowners and businesses who incurred storm-related damage, clean-up and repair expenses are also eligible for a grant to facilitate their recovery. The grant will provide \$1,000 for uninsured expenses beyond \$2,500. The application forms for homeowners and businesses are also attached for Council's information.

Several of the potential recovery grant applicants have participated in the Energy Efficiency Englewood (E3) program, which provides home energy improvements to income-qualified and owner-occupied homes. For these and other income-qualified recovery grant applicants, the grant limits will be expanded to cover 80% of eligible expenses, up to \$5,000, which is similar to how the E3 program is administered. The funding source for all of the residential grants will be the Housing Rehabilitation Fund, which provided funding for home rehabilitation in Englewood from 1978 to 2014.

In terms of grant applications that may be denied, Council requested information about a possible appeal process. All grant applications will be reviewed by Community Development Department staff and a recommendation for approval/denial will be provided to the Director of the Community Development Department. If the Director denies a grant application, the applicant may appeal the decision to the City Manager. Any applicant who is denied a grant by the Community Development Department will be informed of this appeal option.

As of August 14, seventeen residential property owners have formally requested assistance grant applications. Six completed applications have been returned and Community Development staff is working with those applicants to secure the necessary receipts from contractors or service providers in order to process the grants for payment. One application for a business recovery assistance grant from a commercial business in the 3300 block of Broadway has been received. The funding source for business recovery assistance grants will be the economic development program portion of the 2018 Community Development budget.

Community Development and Public Works collaborated to provide dumpsters in the downtown area (in the public parking lots on east side of the 3400 and 3500 blocks of S Broadway) after the storm to enable clean-up and recovery within the business community. Businesses in the 3300/3400/3500 blocks of S Broadway were notified by hand-delivered flyer and through the City's social media channels. (These businesses also received the business recovery assistance grant information and application). After several days, the dumpsters were removed due to very low utilization. A copy of the flyer that was distributed is also attached.

STORM ASSISTANCE GRANT FOR HOMEOWNERS

On Tuesday, July 24, 2018 a severe storm hit the City of Englewood causing damage to many residential homes. The City of Englewood Community Development Department is offering a Storm Assistance Grant to Englewood homeowners impacted by the storm.

To further assist homeowners, the City is waiving select building permit fees and fees for dumpsters that are placed in the public right-of-way through November 30, 2018. While select permit fees are being waived, building permits and public right-of-way permits are still required for work being completed.

City of Englewood staff may require additional information to verify that the expenses are directly related to storm damage.

Grant Information:

- 1. The maximum grant is \$1,000 for a minimum of \$2,500 of eligible expenses
- 2. Applications are accepted on a first come basis
- 3. Grants are available to Englewood residential homeowners
- 4. Residential rental properties are eligible; owner occupancy is not required
- 5. Grants are paid on reimbursement of paid receipts of eligible expenses
- 6. Payment will be to the property owner
- 7. Work must be completed and invoices paid by November 30, 2018

Grant Requirements:

- Submit a completed application to the City of Englewood Community Development Department, 1000
 Englewood Parkway, Englewood, Colorado or via email commdev@englewoodco.gov
- 2. Provide an itemized list of all storm related expenses
- 3. Provide confirmation that expenses are not covered by insurance
- 4. Provide paid receipts when seeking reimbursement

Approved Work Items, Include But Are Not Limited To:

(Damage Must be Related to the July 24 Storm)

- 1. Repair or replacement of windows, awnings, and screen doors
- 2. Repair or replacement of roofs, gutters, other exterior elements
- 3. Drywall repair
- 4. Repair or replacement of flooring, such as tile, wood, or carpeting
- 5. Electrical work
- 6. Repair or replacement of furnaces and hot water heaters
- 7. Costs to mitigate or remove water damage. Examples include: cost for pumps, dryers, roll off trash receptacles, or costs to hire third party restoration companies to mitigate water damage.

Non-Eligible Expenses Include, But Are Not Limited To:

- 1. Personal property
- 2. Lodging and meals if dislocated from home
- 3. Expenses that are covered by insurance

Small Business Recovery Assistance Grant

On Tuesday, July 24, a severe storm hit Arapahoe County with much of the damage concentrated in and around the City of Englewood. The damage to commercial structures and businesses ranges in intensity, but storm related damage has occurred throughout the community.

The City of Englewood Economic Development's Office is offering a Small Business Recovery Assistance Grant to businesses or commercial property owners impacted by the July 24 storm. The maximum grant is \$1,000 and requires the business or property owner to have incurred a minimum of \$2,500 in storm related expenses, which are not covered by insurance. Further, Englewood is waiving select building permit fees and fees for dumpsters placed in the public right of way; however, building permits and public right of way permits are still required for work being completed.

City of Englewood staff may require additional information to verify that the expenses are directly related to storm damage.

Grant Information:

- 1. The maximum grant is \$1,000 for a minimum of \$2,500 of eligible expenses
- 2. Applications are accepted on a first come basis
- 3. Grants are available to a business or commercial property owner
- 4. Grants are paid on reimbursement of paid receipts of eligible expenses
- 5. Payment is to the party that incurred the storm-related damages
- 6. Work must be completed and invoices paid by November 30, 2018

Grant Requirements:

- Submit a completed application to the City of Englewood Economic Development Department, 1000 Englewood Parkway, Englewood, Colorado or via email commdev@englewoodco.gov
- 2. Provide an itemized list of all storm related expenses
- 3. Provide confirmation that expenses are not covered by insurance
- 4. Provide paid receipts when seeking reimbursement

Eligible Expenses Include, But Are Not Limited To:

(Damage must be Related to the July 24 Storm)

- 1. Cost to repair or replace flooring, such as tile, wood, or carpeting
- 2. Cost to repair or replace roofing, awnings, gutters, windows, or other exterior elements
- 3. Damage to electrical, plumbing, mechanical, walls, and other structural damage
- 4. Costs to mitigate or remove water damage. Examples include: cost for pumps, dryers, roll off trash receptacles, or costs to hire third party restoration companies to mitigate water damage.

Non-Eligible Expenses Include, But Are Not Limited To:

- 1. Personal property, equipment, or inventory
- 2. Lost revenue or wages due to store closure or cleanup
- 3. Expenses that are covered by insurance; insurance deductible
