Title 11, Chapter 5, "The Tree and Shrub Ordinance" of the Englewood Municipal Code authorizes the City to order the removal of existing trees where their existence is injurious to the health and safety of citizens or property. E.M.C. 11-5-8(A). Any order to remove an injurious tree shall be served upon the person responsible or upon the property where the condition exists. The failure of a responsible person to remove an injurious tree is a Municipal ordinance violation for which the responsible person may be cited and summoned into Municipal Court. E.M.C. 11-5-6(D). The prosecution bears the burden of proof at trial to prove each and every element of the crime charged beyond a reasonable doubt. Reasonable doubt means a doubt based upon reason and common sense which arises from a fair and rational consideration of all of the evidence, or the lack of evidence, in the case. It is a doubt which is not a vague, speculative or imaginary doubt, but such a doubt as would cause reasonable people to hesitate to act in matters of importance to themselves. COLJI-Crim. E:03 (2015).

In regards to an alleged injurious tree located in the 4800 block of South Lincoln Street, the City Attorney's Office was provided the following information by Code Enforcement. In December 2015, the property owner of 4884 South Lincoln Street filed a complaint with Code Enforcement about a dead/dying tree at 4896/4898 South Lincoln Street (duplex property). The property at 4884 South Lincoln Street shares a property border with the duplex property at 4896/4898 South Lincoln Street. Code Enforcement visited the properties and learned that the tree in question sits on the shared border between the two properties. Although requested by Code Enforcement, neither property owner would grant Code Enforcement permission to enter their property to conduct a thorough inspection. Code Enforcement concluded from its visual observations of the tree from the street that the tree rests on the property line. In reaching this conclusion, Code Enforcement viewed the tree in relation to an existing fence that stands between the two properties on the shared border. The fence stops at the base of the tree but if the fence were to continue to the sidewalk, the fence would split the tree in half. Using the fence as the assumed property border, Code Enforcement concluded that the tree rests on the property line between the two properties. Code Enforcement was later able to gain entry to the backyard of 4896/4898 South Lincoln Street through a tenant, and using the same assumed property boundary of the fence, from this view the majority of the tree appears to sit on the property of 4896/4898 South Lincoln Street.

Although Code Enforcement used the existing fence as the assumed property line, after claims made by both property owners, the validity of the fence as the true property line was called into

question. The property owner of 4896/4898 South Lincoln Street claims that the fence was built without permits by the property owner of 4884 South Lincoln Street and does not accurately represent the property line. The property owner of 4884 South Lincoln Street claims that the fence was built by the owner of 4896/4898 South Lincoln Street. Code Enforcement's search of Permit TRAK for prior fence permits revealed the last permit pulled was for 4884 South Lincoln Street in 1991. It is obvious by the condition of the existing fence that the fence has been rebuilt since 1991. Consequently, Code Enforcement's observations of the tree in relation to the existing fence provide no merit.

The complainant indicated to Code Enforcement that he has reported this tree several times in the past as far back as ten years ago. Code Enforcement checked and rechecked their historic records and found no prior history of dead/dying trees at either address. The property owner of 4896/4898 South Lincoln Street claims that in the past the owner of 4884 South Lincoln Street has spoken to him directly and claimed ownership of the tree along with making threats if he ever tries to touch or cut down the tree. The property owner of 4884 South Lincoln Street denies ownership of the tree but did inform Code Enforcement that he has maintained and cut branches that hung over his property for thirty-five years and that the other property owner has never in thirty-five years spent any time or money trimming the tree. According to the assessor page the current owner of 4896/4898 South Lincoln Street purchased the property in the year 2010. Based upon their investigation, Code Enforcement is unable to determine when the tree was planted, who planted the tree, which property the tree was planted on, or which property the tree currently sits.

Property line disputes are matters to be resolved within a civil proceeding. In a case involving alleged destruction of four trees which allegedly grew on the boundary line between properties, the court relied on the facts provided by a survey of the land that showed the majority of the diameter of each of the four trees extended onto the defendant's land. Rhodig v. Keck, 421 P.2d 729 (Colo. 1966).

In order for the injurious tree located in the 4800 block of South Lincoln Street to come before the attention of the Municipal Court, the responsible person must first be established. To prosecute, this fact would have to be proven beyond a reasonable doubt. The City does not conduct surveys of the land nor does the City have official survey maps. Considering the tree in question visually appears to sit on the property line of the two properties, neither party is cooperative with Code Enforcement and neither party accepts responsibility for the tree, the responsible party is unable to be established much less proven beyond a reasonable doubt.

Both parties deny ownership. Each party claims the other is the owner. Neither party accepts responsibility. The parties cannot agree on who or when the tree was planted. Each party claims the fence dividing the properties was built by the other, and there is no information as to when the fence was built or if it even sits on the plotted property line.

In conclusion, the prosecution would be unable to prove a case against either property owner for the alleged injurious tree located in the 4800 block of South Lincoln Street. Hence, because the City is unable to prove a case beyond a reasonable doubt, the issue becomes one of a civil nature. Thus, the parties can do one of the following:

- 1. The parties can agree to share the cost of removing the tree.
- 2. One of the parties can take full responsibility and remove the entire tree.
- 3. The property owner of 4884 South Lincoln Street can remove that half of the tree which extends over his property.

Request from Council Member Cuesta: What is legal and not legal regarding short term rentals?

Residential short term rentals (STR), also known as vacation rentals, have become a popular alternative housing option for vacationers throughout Colorado. Services such as AirBnB, Homeaway, VRBO, and a multitude of other online booking companies have created a service industry for people seeking short term visitor accommodations in private homes, especially in areas where hotels are expensive or where other quality lodging does not exist. The actual number of STR properties located in Englewood is not known, however, there is a presence of STRs listed on rental websites with locations in Englewood, Colorado.

The Unified Development Code does not list residential short term rentals (less than 30 days) as a use within Title 16. Chapter 5 of Title 16 states a determination may be made to permit, permit conditionally or permit as a limited, accessory or temporary use any use otherwise unlisted in the Code in a zoning district that has a use similar in nature, function, and duration to other uses allowed in a specific zoning district. Because of the nature of operating a short term rental in residential neighborhoods and as the STR use has more recently become an occurrence locally and nationally, there is not a similar use in which to compare in the Unified Development Code.

In cases where rentals are offered for greater than 30 days, the rental is considered as household occupancy which is permitted in residential districts. Some property owners utilize the mentioned websites to list their properties but state in the advertisement that the property must be rented a minimum of 30-days to qualify as household occupancy, thus complying with existing City regulations. Short term rentals in private homes are not currently inspected by the City and may not meet the same health and safety requirements of hotels and other visitor accommodations. Additionally, the City is not currently collecting taxes on these rentals as would occur on other lodging accommodations. Additionally, short term rentals can also have impacts to a neighborhood related to noise, parking and other impacts of visitors.

Currently the Planning and Zoning Commission is developing language to present to the public at an Open House on September 20th in the Community Room at the Civic Center beginning at 6:00P.M. The meeting is the initial step in discussing this use and the potential language to be included in an



Ordinance to City Council. The proposed zoning regulations will need to be adopted addressing the time, place, and manner of such uses. In addition to zoning regulations, licensing, taxation and public safety provisions of the Municipal Code also need to be addressed.
