Information requested as to the source of data used in grant application for

VOCA, including current population stats.

During workshops to prepare for the application of the VOCA Grant, applicants were encouraged to use multiple sources of data to describe the population that the Grant would serve. Grant Administrators suggested the use of Census Data, The American Community Survey data, the GIS Study funded by the Department of Justice, Community statistics, and Department statistics.

All of these sources of data were reviewed as well as Staff knowledge of community agencies serving Englewood. Please find attached the Census Data, crime statistics from the Colorado Bureau of Investigations, Community Development population growth estimates, Victim Compensation statistics, as well as statistics on students qualifying for free and reduced lunch.

The current population of Englewood from the latest census is 34,407. Community Development estimates that will potentially increase to 35,306 through 2018.

Regarding the second question, per EMC 4-4-2, under Definitions – Retailer: "Retailer shall include any: C. Charitable organization or governmental entity which makes sales of tangible personal property to the public; notwithstanding the fact that the merchandise sold may have been acquired by gift or donation or that the proceeds are to be used for charitable or governmental purposes."

The Communications Budget for 2019 does not include any funds directly allocated to a holiday parade. This event has been a cooperative endeavor with the Greater Englewood Chamber of Commerce for the past several years. At the December 17, 2017 Study Session, then Communications Manager Alison Carney presented information that outlined the signature events included in the Communications Budget: Fourth of July, Sounds of Summer concerts, and the Englewood Block Party. The understanding with the Chamber at that time was that they would assume overall responsibility for the holiday parade with minimal City support either in dollars or staff time. The 2019 budget was prepared based on the same assumptions of support for special events.

The Communications Department has scheduled a Study Session for February 25, 2018 to discuss both special events and overall communications strategy. The team will present budget options and request direction from Council at that time to evaluate plans for 2019 special events.
