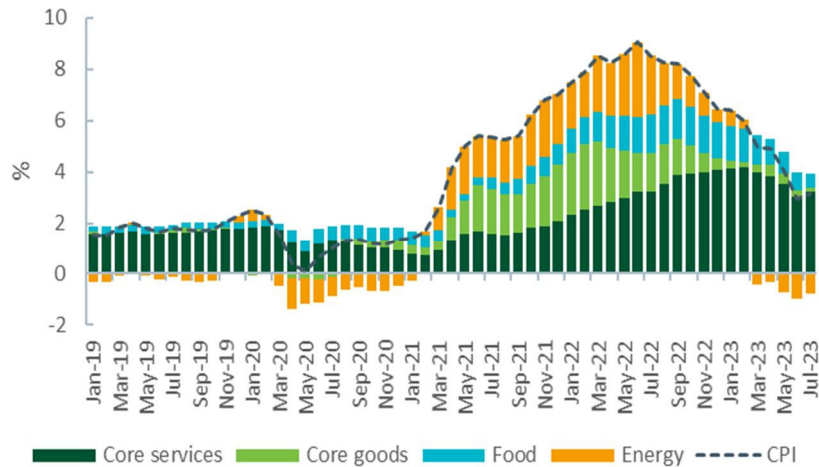

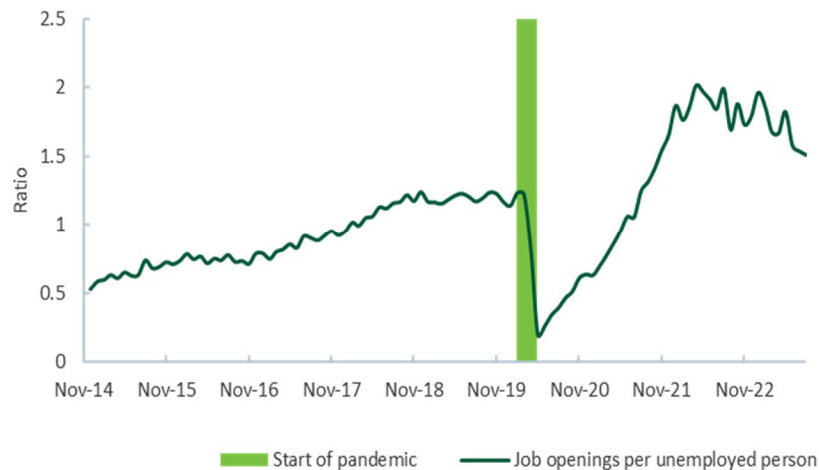

Economic Indicators and Monetary Policy

Fed chair Powell delivered a balanced address at Jackson Hole, largely placating both “dovish” and “hawkish” investors alike. He reaffirmed that the process of getting inflation to 2% has “a long way to go”, and he stated that the committee needs to proceed “carefully” and remain “agile” given the lagged impact of policy tightening.

Nominal CPI increased from 3% year-on-year last month, to 3.2% in July, but slightly lower than the 3.3% expected by the market. This was the first rise since its peak level (of 9.1%) in June 2022. Importantly, core CPI continued to make progress, albeit at a slower pace than last month, slowing from 4.8% year-on-year to 4.7% year-on-year (in line with market expectations). Airline fares and used cars were the largest index detractors, with shelter the largest positive contributor.

The second estimate of Q2 GDP reflected growth of 2.1%, down from 2.4% but still equal to Q1 GDP growth of 2.1%. Business investment was the main category to be revised down, but the category still reflects significantly faster growth than in Q1.

Labor market conditions remained tight overall but showed some signs of easing. Payrolls grew at a solid 187,000 pace, albeit lower than consensus at 200,000 and similar to the previous month. Goods-related hiring continued to be soft, while services-based hiring remained strong although post-pandemic winners like the leisure and hospitality sector slowed. The unemployment rate fell to 3.5% from 3.6% and wage growth picked up slightly to 4.4%, with notable gains in the manufacturing and construction sector.

Job openings fell to 8.8 million, the lowest since March 2021. This meant the ratio of job openings to unemployed fell to 1.5, still higher than pre-pandemic levels of 1.2, but lower than the ~2 to ~1.7 region where the measure has tended to fall over the last 18 months.

Interest Rate Summary

Yields generally rose at the long end of the curve, reducing the inversion but reflecting “higher for longer” interest rates. At the end of August, the 3-month US Treasury bill yielded 5.47%, the 6-month US Treasury bill yielded 5.51%, the 2-year US Treasury note yielded 4.87%, the 5-year US Treasury note yielded 4.26% and the 10-year US Treasury note yielded 4.11%.

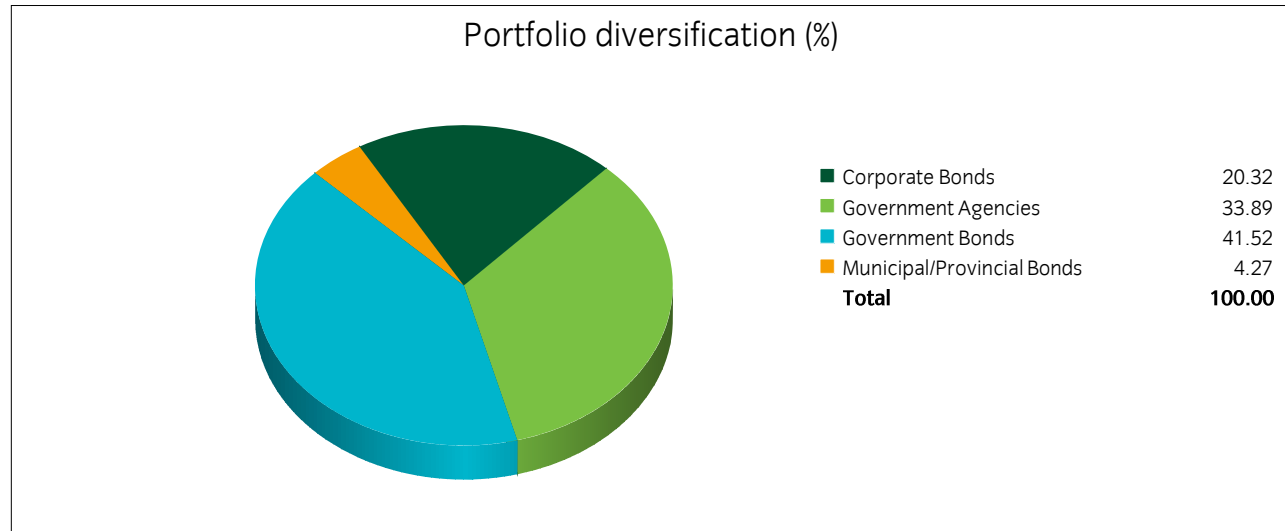

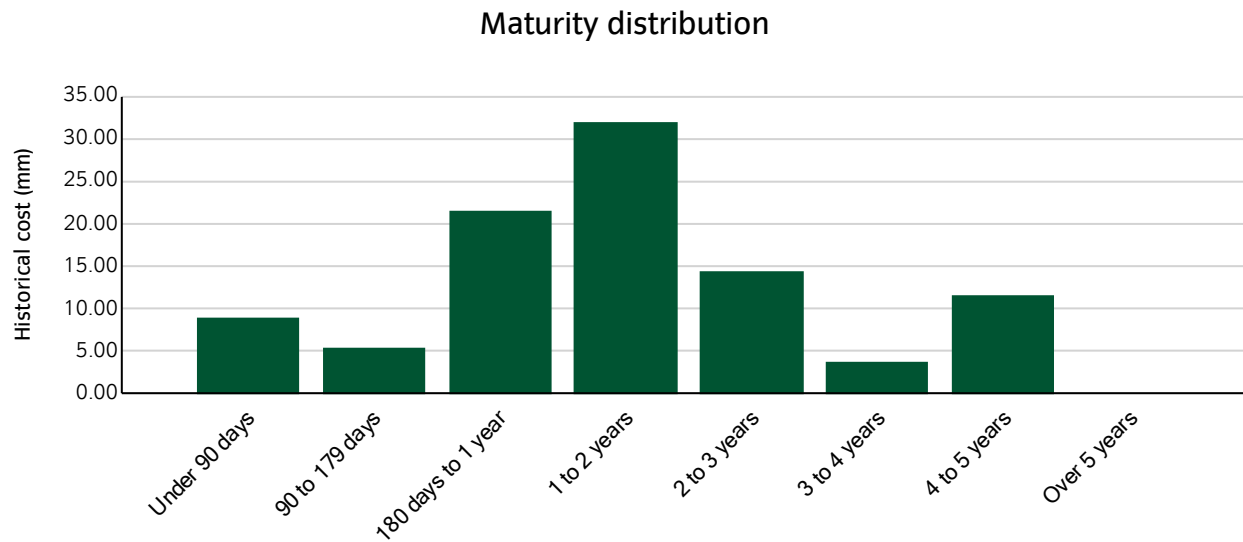
