

Thank you for choosing Broken Tee Golf Course to host your 2024 Tournament. To reserve your spot, please fill out and return this contract.

TOURNAMENT RULES

- Tournament deposit of (10%) must be paid at contract signing.
- Remaining tournament fees (based on a minimum guarantee not less than the stated course minimums) must be paid by the tournament contact no less than (10) days prior to the tournament date. Fees for additional players must be paid the day of the tournament.
- If the payment of and monies payable under the terms of this agreement shall not be paid when due, a late payment charge equivalent to (10%) of the amount, which remains unpaid, shall be added to the total tournament fee.
- Refunds will not be issued for a lower number of players on the contract unless course management is notified (10) days prior to the event.
- Any special course set up conditions must be requested (10) days in advance.
- A detailed list of player pairings are due no later than (5) days before event and must be emailed to tgunkel@englewoodco.gov, mmoran@englewoodco.gov & sbuccio@englewoodco.gov
- If, in the sole judgment of Broken Tee Golf Course, the courses are unplayable due to inclement weather or other catastrophe, the tournament director shall have the option to applying the tournament fees paid to Broken Tee to a future tournament date or refunded after deducting any applicable fees. After 14 holes have been played, no refund will be given.
- Unless authorized by Wyatt's at Broken Tee, players or tournament sponsors are NOT PERMITTED TO BRING OUTSIDE FOOD OR BEVERAGE onto Broken Tee property.
- Outside Alcohol is not permitted under the Public Consumption Section of the Colorado Liquor Code 44-3-901(I). Alcohol brought on the premises will be confiscated and violators may be prosecuted.
- Broken Tee reserves the right to refund and/or refuse service to any player at any time.
- Golf carts will be rented only to those playing in the tournament. If additional carts are needed for volunteers or sponsors, arrangements must be made in advance with Broken Tee.
- Any damage to golf property shall be repaired/replaced at the expense of the tournament chairperson and/or the individual player.
- Our "3 contact" pace of play policy is strictly enforced, and groups will be removed for lack of compliance with no refund given. Each group is expected to complete their round in (4) hours and (30) minutes.
- Discount programs are invalid for Tournament play.
- All players will comply with course rules and customary golf etiquette.
- TOURNAMENT SPONSOR AGREES TO INDEMNIFY, HOLD HARMLESS AND REIMBURSE BROKEN TEE GOLF COURSE AND THE CITY OF ENGLEWOOD. AND THE AGENTS THEREOF, FROM AND AGAINST CLAIMS, DAMAGES, LOSSES AND EXPENSES, INCLUDING ATTORNEY'S FEES, ARISING OUT OF OR RESULTING FROM ANY BODILY INJURY, SICKNESS, DISEASE, DEATH OR DAMAGE TO PROPERTY INCLUDING GOLF CARTS (OTHER THAN NORMAL WEAR AND TEAR) CAUSED, IN WHOLE OR IN PART, BY ANY WILFUL OR NEGLIGENT ACT OR OMISSION OF ANY MEMBER(S) OF THE TOURNAMNET SPONSOR, INCLUDING BUT NOT LIMITED TO TOURNAMENT SPONSOR EMPLOYEES, BOARD MEMBERS, VOLUNTEERS AND CONTRACTORS AS WELL AS PLAYERS IN THE TOURNAMENT.
