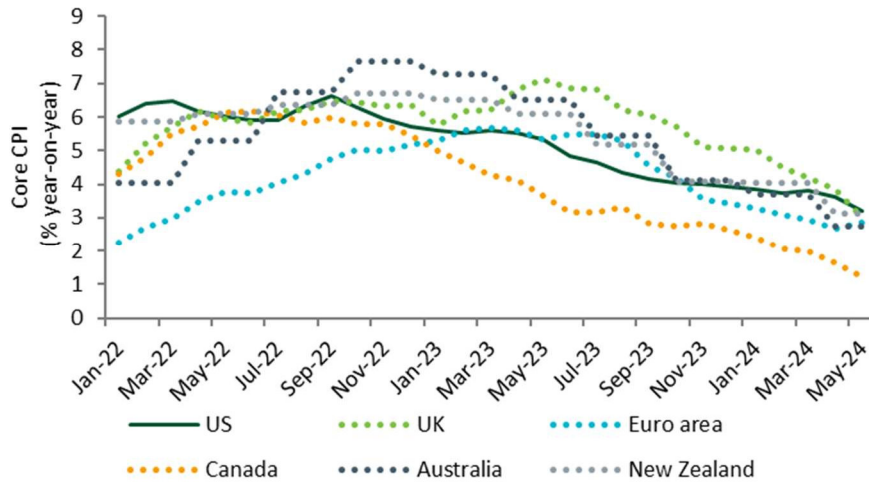

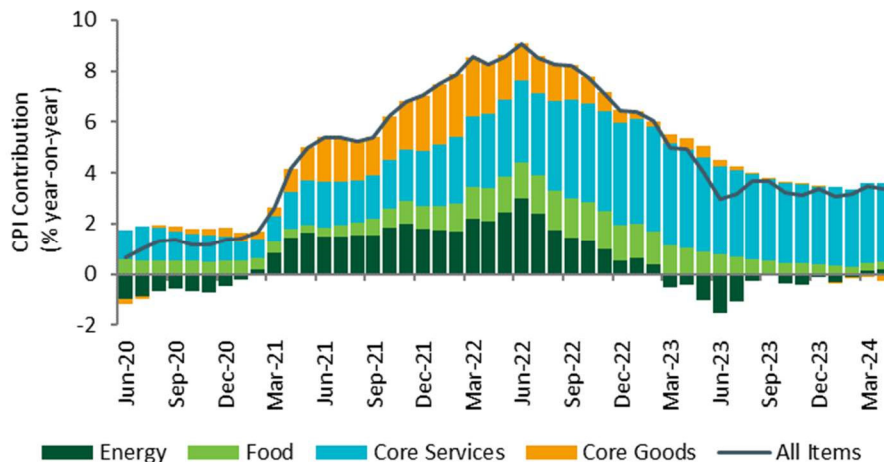

Economic Indicators and Monetary Policy

Headline CPI came in lower than expected for the first time this year, at 0.3% in April. Core prices also rose 0.3% (in line with expectations). This took headline CPI from 3.5% to 3.4% year-on-year and Core CPI from 3.8% to 3.6% (the lowest since April 2021). Core services categories remained the largest contributors to inflation given their “sticky” nature. The “supercore” categories (core services excluding shelter) remained particularly stubborn, rising to 4.9% from 4.8% year-on-year, although slowing on a month-on-month. CPI in the US is declining at a slower pace compared to other countries (Chart 1).

The second GDP growth estimate for Q1 2024 was at 1.3% pa, down from 1.6%, but in line with market expectations. The significant change across the major categories was a downward revision in consumption, with goods consumption in negative territory.

Employment rose by 175,000 jobs in April, softer than consensus expectations at 240,000. Private employment rose by 167,000. Private education and health care were strong, rising by 95,000 jobs in April with 87,000 of that in health care and social assistance. Wage growth was more modest than expected at 0.2% month-on-month and 3.9% year-on-year. The unemployment rate rose to 3.9%, from 3.8%.

The FOMC left the Fed Funds rate unchanged but amended its official statement to add that “In recent months, there has been a lack of further progress toward the Committee’s 2 percent inflation objective”. This reflects disappointing inflation prints so far this year. Chair Powell stated “gaining greater confidence” that inflation will sustainably return to target may take longer than previously expected and the central bank is prepared to keep rates unchanged as long as appropriate. Elsewhere, Chair Powell announced the Fed will slow quantitative tightening in June to ensure there are “ample reserves” in the system. The Fed will allow a monthly cap of \$25bn of Treasuries to roll off its balance sheet, down from \$60bn, and it left the \$35bn cap on mortgage-backed securities unchanged.

Interest Rate Summary

Yields generally fell during the month. At the end of May, the 3-month US Treasury bill yielded 5.39%, the 6-month US Treasury bill yielded 5.38%, the 2-year US Treasury note yielded 4.87%, the 5-year US Treasury note yielded 4.51% and the 10-year US Treasury note yielded 4.50%.

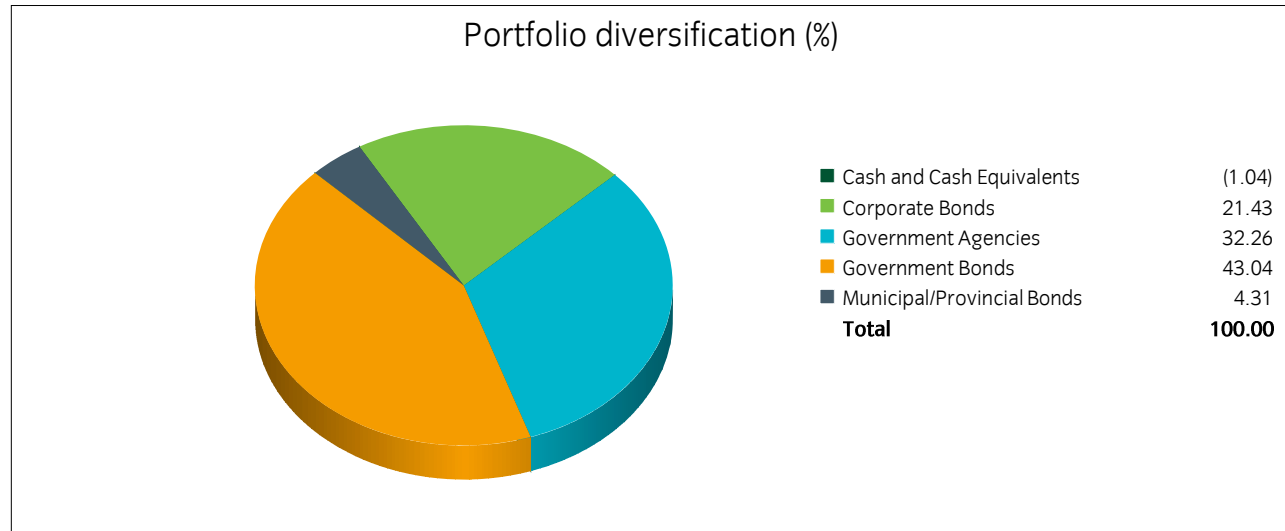

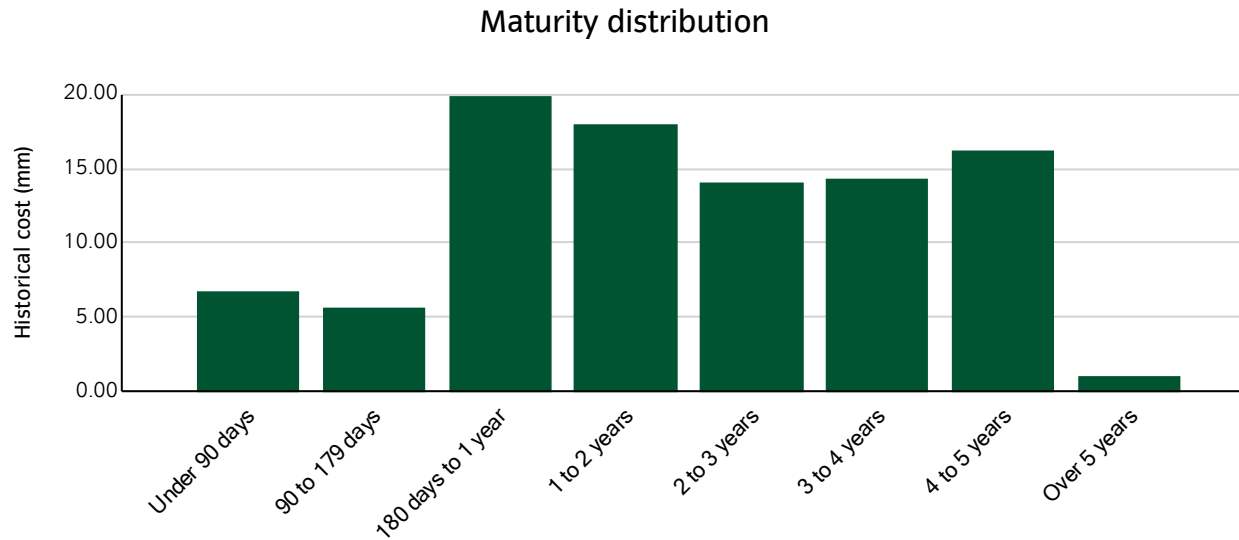
