**NOTICE OF COORDINATED ELECTION  
NOVEMBER 5, 2024**

**Notice is hereby given that in accordance with the Englewood Home Rule Charter, Ordinance No. 30, Resolution No. 24, and Resolution No. 25, Series of 2024, a Special Municipal Election for the City of Englewood, County of Arapahoe, State of Colorado, will be held in conjunction with the Coordinated General Election to be conducted by the Arapahoe County Clerk and Recorder on November 5, 2024.**

The November 5, 2024 Coordinated Election will be a Mail Ballot Election.

The ballot for Englewood voters will include one referred TABOR issue and two citizen-initiated Charter Amendment questions. It may also include State and/or County questions.

Listed below is the City of Englewood ballot measures certified by the City of Englewood City Clerk, to the Arapahoe County Clerk and Recorder, to be decided upon at the November 5, 2024, General Coordinated Election.

Referred Ballot Issue # 2C

SHALL THE CITY OF ENGLEWOOD DEBT BE INCREASED UP TO \$ 41.5 MILLION, WITH A MAXIMUM REPAYMENT COST OF UP TO \$72 MILLION, AND SHALL CITY TAXES BE INCREASED UP TO \$4 MILLION ANNUALLY FOR THE PURPOSE OF IMPROVING, REPAIRING, EQUIPPING AND UPGRADING THE CITY'S PARKS AND RECREATION FACILITIES AND AREAS TO INCLUDE, BASED ON AVAILABLE FUNDS:

- IMPROVEMENTS TO BARDE PARK, BELLEVIEW PARK, CLARKSON-AMHERST PARK, CUSHING PARK, MILLER FIELD, NORTHWEST GREENBELT, ROTOLO PARK, EMERSON PARK, ENGLEWOOD RECREATION CENTER, AND PIRATES COVE, INCLUDING NEW RECREATIONAL FACILITIES, IRRIGATION UPDATES TO REPLACE AGING EXISTING IRRIGATION SYSTEMS,

BY THE ISSUANCE AND PAYMENT OF GENERAL OBLIGATION BONDS, WHICH SHALL MATURE, BE SUBJECT TO REDEMPTION, WITH OR WITHOUT PREMIUM, AND BE ISSUED, DATED AND SOLD AT SUCH TIME OR TIMES, AT SUCH PRICES (AT, ABOVE OR BELOW PAR) AND IN SUCH MANNER AND CONTAINING SUCH TERMS, NOT INCONSISTENT HEREWITH, AS THE CITY COUNCIL MAY DETERMINE; AND SHALL AD VALOREM PROPERTY TAXES BE LEVIED WITHOUT LIMIT AS TO THE MILL RATE TO GENERATE AMOUNTS, NOT TO EXCEED THE ABOVE AMOUNTS, SUFFICIENT IN EACH YEAR TO TIMELY PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS?

Charter Amendment to Directly Elect the Mayor

Initiated Ballot Question # 302

Charter Amendment Increasing the Number of City Council Votes to Fill a Council Vacancy, Requiring Election if Vacant over 30 Days

To guarantee a broader community consensus for appointments of vacated positions on City Council and to protect the interests of Englewood voters, shall there be an amendment to the City Charter Section 28 requiring a supermajority vote of no less than 75% of the remaining Council Members for the appointment of a vacated position, and if a vote cannot be reached within 30 days, and the vacancy occurs greater than 6 months from any general municipal election, such vacancy shall be referred to a special election for the respective unexpired term, otherwise the position will be held vacant until the next general municipal election?

**The deadline to return completed ballots is 7:00 p.m. on Election Day, November 5, 2024.**

Ballots received **after** that deadline will not be counted.

Arapahoe County voters can drop off their Mail Ballots in the secure 24-hour Mail Ballot drop-off box on the northeast side of Englewood Civic Center, 1000 Englewood Parkway, accessible from our circular driveway (across from the fountain) or at the Arapahoe County Public Health Department located at 4857 South Broadway.

The Englewood Civic Center will be a Voter Service & Polling Center for this election.

Arapahoe County citizens may also visit any of the Voter Service and Polling Centers between October 21<sup>st</sup> and November 5<sup>th</sup> to:

- Drop-off a voted mail-in ballot
- Register to vote in-person
- Update voter registration
- Request a replacement ballot if your ballot was damaged or missing
- Request to vote in-person
- Language interpretation service available
- Vote on an accessible electronic ballot marking device
